TRUST STARTS WORK TO REFURBISH AND RESTORE NO 5 CHARLOTTE SQUARE

Conservation charity the National Trust for Scotland has confirmed that a programme of repair and refurbishment has commenced at No 5 Charlotte Square, one of Edinburgh's most prestigious addresses.

The works will include repairing the external fabric of the building in the World Heritage Site, improving accessibility with the installation of a lift, and sustainability with the fitting of solar panels.

Inside, the building is being fit out to function as an office for the conservation charity. It will be used as a main office as part of its network of flexible workplace hubs for staff and volunteers, with entry expected in late 2026.

Stuart Maxwell, Regional Director for Edinburgh & East is leading the project. He said: "This is an ambitious refurbishment project of an incredibly important heritage building, designed in the 18th century by Robert Adam, and in the heart of the World Heritage Site of the New Town. Our works will create a modern and functional workspace that preserves and highlights the building's historic significance and charm and adheres to exemplary heritage and building conservation standards."

A series of repairs will also be carried out at the National Trust for Scotland's Georgian House, at No 7 Charlotte Square. This historic property is open to the public and provides an insight into the lavish lifestyle of a wealthy family, living at one of the most fashionable addresses in Edinburgh in the 18th century. It will remain open and accessible to the public throughout the works.

Contractors Morris & Spottiswood Group will deliver the project. Paul Beaton, Development Director at Morris & Spottiswood said "This appointment reinforces our position as a leading heritage contractor. Working on such an iconic building in Charlotte Square, while managing the many facets of a project of this scale and profile, showcases our expertise in complex listed building projects."

Notes to editors

The National Trust for Scotland owns no 5, 6 and 7 Charlotte Square. The buildings were transferred to the National Trust for Scotland in 1966 by the Marquess of Bute. No 7, known as the Georgian House is open to the public, providing an insight into life as it would have been soon after the square was built. No 6, also known as Bute House, is the official residence of the First Minister.
